

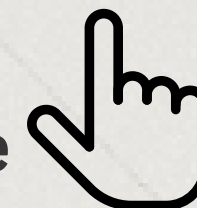

WHAT TO DO WHEN A FAMILY MEMBER IS DETAINED

Timing is critical. You must react quickly because the system can change unpredictably.

You are not alone. Talk to a trusted adult at RBR. We can help you navigate the process.

FIRST STEPS



2.

COMPLETE THE DDDI FORM

New Jersey's Detention and Deportation Defense Initiative (DDDI) is a state-funded program, administered through the New Jersey Department of Human Services Office of New Americans.

To report a raid, use the AFSC form.

1. LOCATE THE DETAINEE

You may not find the person for up to 72 hours. Use the Detainee Locator System (Need A-Number OR DOB, Full Name, Country of Birth)

GET LEGAL COUNSEL ASAP

Retain legal counsel ASAP.

- Habeas corpus petition must be approved by a federal judge. It can prevent ICE from transferring out of state and expedites a bond hearing. If you cannot pay for an attorney, contact community organizations. If you are going pay for a lawyer, try to choose a vetted attorney who is recommended by trusted people:

HOW TO PAY A BOND

CONSIDER THE PROCESS:

If a judge awards a bond, you can pay it in person with a cashier's check at 970 Broad Street, 11th floor at the Newark Bond Office. You must be approved as an 'obligor' and provide proof of legal residency in the U.S. They ask for 2 IDs with your address. One must be a REAL ID. The bond is returned to the obligor if the person attends all immigration hearings. *Paying in person is faster, but expect to wait a long time.

NOTE: IT MUST BE PAID AS QUICKLY AS POSSIBLE. SOMETIMES THE BOND CAN BE OVERTURNED AT A STATUS CONFERENCE FOR A DETAINEE

HOW TO TRANSFER **TEMPORARY** POWER OF ATTORNEY

POA LETS A TRUSTED ADULT MAKE DECISIONS ABOUT:

- medical and mental health care

- expires after one year unless renewed

WHAT **NOT** TO DO



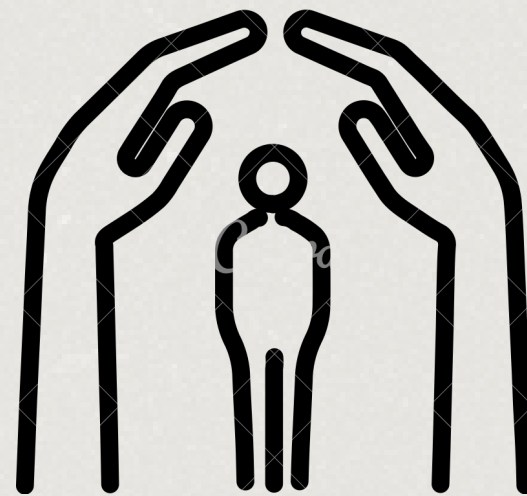
Don't get close to them. Do NOT interfere with their operation in any way.

Response hotline.

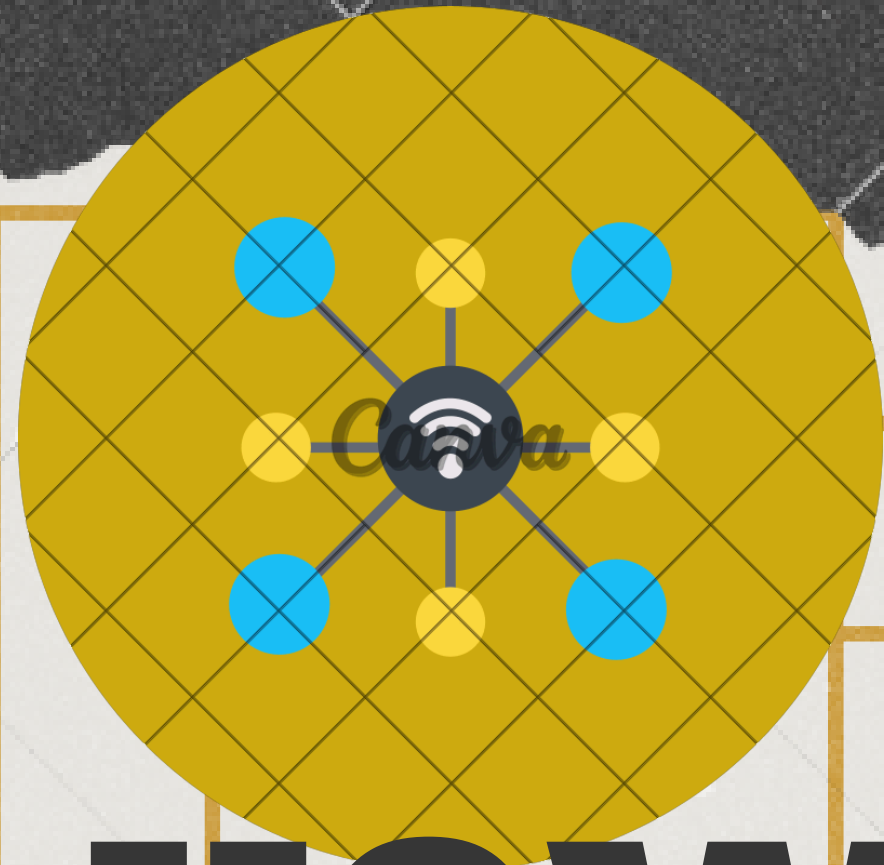


RAPID RESPONSE IN NJ

WHAT IS IT?

A community network that documents ICE activity, provides immediate support to affected families, and connects people with legal resources and Know Your Rights information.

WHAT TO DO AT HOME

DO NOT OPEN THE DOOR

ICE cannot enter without a judicial warrant signed by a judge

KEEP CALM AND STAY SILENT

You have the right to remain silent under the 5th Amendment.

DO NOT SIGN ANYTHING

Do not ever sign anything without speaking to an immigration attorney. Ask for translations when needed.

TYPES OF WARRANTS

JUDICIAL

SEARCH AND SEIZURE WARRANT

WHAT TO DO IN A CAR

IF YOU ARE DETAINED BY POLICE

Stop, turn your hazards on, roll down the window. Keep your hands visible.

Provide license, registration, and insurance when asked

IF YOU ARE DETAINED BY ICE

You do not have to speak or sign anything.

You can refuse a vehicle search.

Do not show false documents.
